Why?	Financial companies choose how they share your financial information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ▪ Social Security number and assets ▪ Account balances and transaction history ▪ Risk tolerance and account information <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>

How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Ronald Blue Trust chooses to share; and whether you can limit sharing.

What we do

How does Ronald Blue Trust protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Ronald Blue Trust collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ▪ open an account or show your government-issued ID ▪ give us your contact information or seek advice about your investments ▪ make deposits or withdrawals from your account <p>We also collect your personal information from other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ Sharing for affiliates' everyday business purposes – information about your creditworthiness ▪ Affiliates from using your information to market to you ▪ Sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>

Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>Ronald Blue Trust does not share with our affiliates so they can market to you.</i> ▪ <i>Our affiliates include companies with a Thrivent name (other than Thrivent Federal Credit Union); financial companies such as Thrivent Financial for Lutherans and Thrivent Investment Management Inc.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ▪ <i>Ronald Blue Trust does not share with nonaffiliates so they can market to you.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ▪ <i>Ronald Blue Trust does not jointly market.</i>

Other important information**Special Notice for California Residents**

In accordance with California law, we will not share information we collect about you with nonaffiliated third parties, except as permitted by law; such as with your consent, to process your transactions or to maintain your account. We will automatically treat accounts with California mailing addresses as if they have limited sharing information with our affiliates.

Special Notice for Vermont Residents

In accordance with Vermont law, we will not share information we collect about you with nonaffiliated third parties, except as permitted by law; such as with your consent or to service your account. We may share information about your transactions or experiences with our affiliates without your consent.
